4. Willing and able to engage in continued AIMS training, missions mobilization, and missionary development.
5. Self-supported and financially responsible.
6. Affirmed and accountable to church leadership in your designated region.
7. Adheres to biblical leadership as outlined in 1 Timothy 3 and Titus 1.
8. Has access to reliable and frequent internet access, and ability to communicate with the AIMS Regional/Country Coordinator and AIMS Home Office, in English, as necessary. If unable to fulfill this requirement, must be capable of communicating regularly with the Regional AIMS Coordinator.

II. **AIMS Partnership Benefits:**

1. Access to ongoing training and materials through your personalized username and password on the AIMS website – or through the Regional AIMS Coordinator for your area.
2. Personal listing as a Certified AIMS Trainer in the *LIGHT3500* Database, if appropriate.
3. Personal contact from AIMS Leadership to provide ongoing development and networking resources.
4. Ongoing interaction with the AIMS UPG Coordination Team and AIMS Training Team.

5. Help in mobilizing your **Faith Promise Giving** training to generate finances for the work of missions among your adopted UPGs and increase missions sending capability.
6. Connection to a worldwide network of UPG-focused ministries and partnership with holistic ministries aiding your Great Commission efforts.
7. Possible financial partnership in **LIGHT3500** towards your specific UPG focus or related missionary work.

- Confirm you understand that you must teach and report at least one AIMS Training activity in a 6-month period to maintain your Trainer Portal credentials.
- Oversee UPG adoptions within your designated region.
- Provide quarterly reports to AIMS and your Regional/Country/Area Coordinator through your personal login account at www.aims.org.
